Alaska Bands Felt-Soles: Last month I reported on Alaska's ban on felt-soled waders. As a result of this ban LL Bean no longer sells any wading products with felt soles. As of the end of February LL Bean destroyed over a million dollars of product to remove the felt soled products from all of their stores. The threat of invasive species moving to clean streams and rivers is serious business. Anyone who is still using felt should visit www.cleanangling.org for the appropriate cleaning of your gear before fishing new water.
